WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Chetana Primary Teacher's Training Institute, At-Bishupuria, PO.-Bishupuria, Ps.-Hura, Dist.-Purulia, West Bengal-723130 has submitted an application (Code No.APE00633) to the Eastern Regional Committee of NCTE for grant of recognition for conducting PTT (D.Ed.) Course with an annual intake of 50 on dt.31.03.2006

- 2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Elementary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Chetana Primary Teacher's Training Institute, At-Bishupuria, Po.- Bishupuria, Ps.- Hura, Dist.- Purulia, West Bengal- 723130 for conducting PTT (D.Ed.) Course of Elementary level of two years duration with an annual intake of 50 from the academic session 2009-2010 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject to fulfillment of the following conditions:

- The admission of students shall be made only after affiliation by the (i) examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010 failing which the recognition will be effective from the academic session 2010-2011 only.
- Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days the session is fulfilled as per the calendar of the University/Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Eastern Regional Committee.
- The institution shall comply with the various other norms and (iv) standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation (V) from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- The institution shall ensure that the required number of academic (vi) staff for conducting the course is always in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - Copy of the Application Form (a)
 - Land and Building Particulars (b)
 - Staff Profile (C)
 - Recognition letter (d)
 - Information for having fulfilled the norms & standard and other (e) required conditions. La aliquerelle

- 7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
